

NATURAL RESOURCES BOARD MEETING Tuesday, November 18, 2014 <u>MINUTES</u>

The Vermont Natural Resources Board convened at approximately 9:33 a.m. on Tuesday, November 18, 2014 at the Dewey Building Conference Room, National Life Drive, Montpelier, Vermont; Chair Ron Shems presiding. Chair Shems welcomed everyone to the meeting and invited everyone to introduce themselves.

1. Guest Speaker

Harry Chen, M.D., Acting Secretary, Agency of Human Services gave a presentation on incorporating Health in All Policies. Discussion afterward focused on how existing Act 250 criteria support public health, and how Act 250 can be used to better address health issues. Although there is no single Act 250 criterion that expressly focuses on health, several criteria do address health, such as Criterion 1(air/noise), 4 (water supply) and the new Criteria 5(B) and 9(L), which incorporates complete streets and smart growth principles which foster walking and other healthful behaviors and environments that Dr. Chen identified as important to public health. The Board and staff expressed interest in continuing to work with the Department of Health



on issues related to Act 250 and health.

2. Approval of Minutes

Bill Davies moved to approve the minutes of the October 14, 2014 meeting as printed with one correction. The motion was seconded by Marty Illick and approved by the Board by a 4-0-1 roll call vote:

3. Office Update, Budget Update & 2015 Outlook (fee bill, etc.)

Lou Borie gave a brief budget update. Lou and Ron met with Commissioner Reardon about the NRB's proposed budget and fee increase. Commissioner Reardon asked that NRB coordinate its fee proposal with ANR.

Bill Davies and Elizabeth Wilkel voiced concerns about the use of Mailchimp. Melanie stated that she would let Kimberley know, so we can follow up regarding their concerns.

Ron Shems mentioned terms expiring of the Natural Resources Board members and the District Commissioners. Elizabeth Wilkel noted that her term expires 1/31/2016.

4. Act 145 (traffic mitigation fees) Vermont Agency of Transportation (VTrans)-NRB Memorandum of Understanding (MOU)

Ron Shems briefed the NRB regarding the draft MOU with VTrans on Act 145 (traffic mitigation fees). The MOU addresses issues such as agency roles and responsibilities in implementing the new law.

Bill Davies made a motion to sign the Act 145 (traffic mitigation fees) VTrans-NRB MOU. The motion was seconded by Elizabeth Wilkel and approved by the Board by unanimous roll call vote:

5. Act 250 Rules – continue reviewing possible amendments

Melanie Kehne reviewed possible revisions to the Act 250 Rules and took suggestions from the Board. The suggestions will be incorporated into the next draft and circulated for comment. Melanie is also discussing the latest draft with the coordinators later this week. The discussion will continue at the Board's December 9 meeting. A telephone meeting is tentatively set for December 16 for a vote to commence rulemaking.

Lou Borie and Ron reviewed draft Rule 21 Master Plan and Partial Review language and took suggestions from the Board. The revised draft will be circulated to the stakeholders for further comment. The discussion will continue at the Board's December meeting.

6. Appeals, enforcement, litigation and attorney-client privileged or work product memoranda (Executive Session)

Don Sargent made a motion to go into executive session in accordance with 1 V.S.A. Sec. 313 (a)(1) and (6) for discussion of attorney-client privileged documents and civil actions by the State where premature public knowledge would clearly place the Board at a substantial disadvantage. Bill Davies seconded the motion, which was approved by unanimous roll call vote:
