## V. <u>CBES (Commercial) Stretch Guidelines Discussion (Commercial Code 9F):</u>

Barry Murphy's Recommendations to update these Guidelines based on the to-be-adopted CBES (source—B. Murphy PowerPoint presented at the November 21, 2019 Board meeting):

- Increase electric vehicle charging requirements
- Increase the number of required points from the additional efficiency packages from 6 to 9
- Increase airtightness from 0.3 CFM/sf to 0.25 CFM/sf for all building
- Retain renewable energy requirement for building over 20,000 sf

General discussion re: Mr. Murphy's recommendations. Mr. Boulbol explained criterion 9(F). Board members expressed interest in additional information for further consideration with respect to new Commercial Stretch Guidelines which may accompany the new base code. Mr. Boulbol will speak with Barry Murphy of the PSD regarding the Board's request for additional information.

# VI. <u>Summary: comparison of executive branch draft legislation and committee bill</u> (continuation from Board meeting on 11/21/19):

#### NRB proposed structure:

General discussion of committee bill's proposal of new Board structure. Board would like to further analyze proposals. Additional documentation concerning proposals located on House committee website. Staff will provide a link to Act 47 & Act 47 Report.

General discussion re: Board involvement with legislative hearings.

#### Burdens of Proof:

The board discussed the Committee Bill's proposal to shift the burden of proof to appellant (regardless of whom the appellant is) when an appeal is taken. Mr. Turner and Mr. Aldrich supported this bill.

#### Racial Justice (22):

Brief, general discussion regarding this proposed provision in the Committee Bill.

#### Update concerning Appeals:

Hinesburg/Hannaford, Act250 Permit issued some time ago within a reasonable amount of time. The Act 250 permit, ancillary ANR permits, and municipal permits have been appealed. As of two weeks ago the developer withdrew their development proposal, as a result no development is currently proposed for this tract in Hinesburg. The town has a proposal to make this land a park. Chair Snelling held a brief discussion on why this property had so many issues/appeals.
