## November 15, 2019

Act 250 Schedule A Form (ver. 2.01; rev 11/15/19) contains the following updates:

- The Master Plan Fee box was moved to above the NRB Fee SubTotal box to correct the calculation error below.
- The Master Plan had calculation errors that allowed the maximum total fee to go above \$165,000, and if there were no construction costs, the minimum fee of \$62.50 or \$187.50 was being incorrectly added.

## **November 1, 2019**

Act 250 Schedule A Form (ver. 2.0; rev 11/1/19) contains the following updates:

- Added a Master Plan Fee box after the Total Fee box, along with a footnote explaining how to calculate the Master Plan fee (if applicable).
- No longer applies an 'ANR Fee' to Administrative Amendment applications.
- Added a check box to the top of the form for residential projects located in State-Designated neighborhoods. When this box is checked, the NRB Fee SubTotal and ANR Fee are automatically reduced by 50%.

# February 28, 2019

Act 250 Schedule G Form (version 2.2; rev. 2/28/19) contains the following updates:

- Schedule G has been converted from a dynamic to a static PDF-fillable form.
- Canadian provinces and territories have been added as options for the applicant's mailing address.
- URLs are now visible so that they can be easily identified in an in-print version of the form.

- All fields, except the secondary project town, are required fields.
- Instructions throughout the form have been edited to provide more clarity for the applicant.
- In the text immediately preceding the project description field, "et seg." has been corrected to "et seg."

#### January 8, 2019

Act 250 Application Form (ver. 2.1; rev. 1/8/19) and Schedule G Form (ver. 2.1; rev. 1/8/19) contain the following updates:

- On Page 1 of the Application, in the header, the version number was changed to 2.1 from 1.9, skipping "2.0", to bring the revision numbering in line with Schedule G.
- On Page 3 of the Application, the applicant is required to submit only 1 complete set of site
  plans to the District Coordinator. In the previous Application version, the applicant was
  required to submit 4 complete sets of the application and all supporting documents (including
  site plans and Schedule G).
- In Schedule G, the name of the form has been changed from "Schedule G Notice of Application Filing" to "Schedule G Notice of **Initial** Application Filing" to distinguish this preliminary application form from a later issued notice of application filing that occurs after the permit application is deemed complete.

#### January 4, 2017

- Revisions to Schedule B Criterion 1(D): (Changes in bold italics)
  - Criterion 1D Floodways: Demonstrate that the Project will not restrict or divert the flow of flood waters, and endanger the health, safety and welfare of the public or of riparian owners during flooding. Floodway Fringe: Demonstrate that the Project will not significantly increase the peak discharge of the river or stream and endanger the health, safety and welfare of the public or of riparian owners during flooding.

River Corridors on streams draining less than 2 square miles are designated on the Atlas as small stream setbacks and will need to be measured on the ground.
